- I understand by enrolling my child in this dance program, I am granting permission for he/she to participate in physical activity. As in any physical activity, there is chance of injury. I am hereby releasing Dance Innovations and their instructors from any and all liability in the case of injury.
- I understand that I am enrolling my child for the 2025-2026 dance season and that I am responsible for 10 monthly payments of \$\_\_\_\_\_ while enrolled. I agree to pay my monthly tuition before the 10<sup>th</sup> of every month. Tuition received after the 10<sup>th</sup> of the month is subject to a \$10 late fee. Bounced checks are subject to a \$30 Bank fee.
- I understand that Tuition is not based on the number of classes per month, but is a total fee for the classes provided from our start date in September to our recital in June. For your convenience, we break the tuition down into 10 payments. Each payment remains the same REGARDLESS of the amount of weeks in the month.
- I understand that tuition & all fees are nontransferable & nonrefundable.
- I understand that Payment #1 is due at registration. Payment's #2-8 are due by the 10<sup>th</sup> of each month beginning in October. Payments 9 & 10 are due by May 10<sup>th</sup>.
- I understand that there are no refunds for missed classes. Any classes that are missed during the month MAY NOT be deducted from the tuition. In the case of absence, make-up classes are available. Make-up classes must be made up within 3 months of absence.
- I understand that tuition is not adjusted for holidays or emergency closings. All school holidays listed in our calendar are already accounted for in the tuition. Also accounted for are 2 emergency/inclement weather closings per day of the week.
